Meeting was called to order by Chairman, Brent Bachmeier.

**AGENDA.** The agenda was reviewed and was followed for the balance of the meeting.

MINUTES. Board members had received a copy of the minutes of the regular meeting of August 9, 2023. After discussion, it was moved by Stangeland, second by Stedman, to approve the minutes of the August 9, 2023 meeting. All in favor. Motion carried. The construction cost-share will be on the Pre-commission agenda on September 13<sup>th</sup> and the Commission meeting agenda on October 12<sup>th</sup>. FOSTER COUNTY ASSESSMENT DRAIN NO. 1- EASEMENT ACQUISITION. No update at this time.

LONGVIEW TOWNSHIP/" LITTLE PIPESTEM CREEK" Jeremiah Blahna, Mark Schneider, Curt Klein, and Dennis Montgomery approached the board about cleaning out cattails, ditch cleanout and creating a common channel. They will obtain bids for the clean out/project and present them to the board at a later date.

**KELLY CREEK/SCOTT'S SLOUGH.** Board member Zink will contact Dakota Helicopters about spraying cattails. Land owner permission slips were received from Jerry Becker, Robert Schaefer, Jeff Wede, and Duane Mullenberg.
